Limited Lifetime Warranty for Professional Auto Repair Businesses

QUALIFYING PRODUCTS: Autopart International VSV Shocks and Struts; Autopart International Pro-Struts

WARRANTY PERIOD

Subject to the conditions and exclusions explained below, this Limited Lifetime Warranty begins on the date the Qualifying Product is installed. Limited Lifetime Warranty does not apply to parts installed on commercial use vehicles which are instead warranted for 90 days from the date of purchase. This warranty cannot be transferred to anyone at any time.

YOUR RESPONSIBILITY

Retain your parts Invoice as it is your proof of warranty. If any part should fail due to a defect in materials or workmanship after proper installation and normal use and service, please return it with your Invoice within the warranty period to any store.

INSTALLATION

Parts must be installed properly on the vehicle for which they were designed. Improper installation voids the warranty.

WHAT IS COVERED

We will, at our option, replace any part that we sell that fails due to a defect in materials or workmanship during the warranty period. The replacement part will be warranted for 90 days from the date of exchange or the remainder of the warranty period, whichever is longer, subject to the conditions and exclusions in this warranty.

WHAT IS NOT COVERED

Warranty does not cover damage or failure resulting from:

- Failure due to accident or collision
- Improper installation of the part
- Misuse, abuse, or modification or for vehicles or parts used off-road or for marine, racing, or entertainment purposes
- Chemical fallout, tree sap, salt, hail, or other environmental, insect or animal causes
- Vehicles under manufacturer's recall for a related problem
- Failure caused by the malfunction of other vehicle parts

THIS WARRANTY DOES NOT COVER INDIRECT, INCIDENTAL SPECIAL OR CONSEQUENTIAL DAMAGES SUCH AS PHYSICAL INJURIES OR PROPERTY DAMAGE, LOSS OF TIME, LOSS OF USE OF THE VEHICLE, INCONVENIENCE, RENTAL VEHICLE CHARGES, TOWING CHARGES OR OTHER ACCOMMODATIONS OR COSTS RESULTING FROM THE FAILURE OF THE PART. Some states do not allow the exclusion or limitation of incidental or consequential damages so the above limitation or exclusion may not apply to you.

It represents the exclusive remedy for warranty failure and the total liability of Autopart International for any part it warrants. AUTOPART INTERNATIONAL MAKES NO OTHER WARRANTIES EXPRESS OR IMPLIED INCLUDING THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. PROCEDURE TO FILE A LIMITED WARRANTY CLAIM:

1. Consumer should return to the installer who performed the original work.
2. Present the warranty product, and original installation receipt to the installer. The installer will contact Autopart International.
3. Autopart International will provide a replacement part to the installer for those claims which are in compliance with the conditions and exclusions of this Limited Lifetime Warranty.
4. Autopart International reserves the right to require return of the defective product where a question of accuracy or authenticity exists.
